Dear Wellesley at Boynton Beach Owners:

This is a notification to Owners regarding requirements for window replacement.

If an Owner wants to replace windows, the Owner is required to properly apply and obtain prior written Association approval.

Design and appearance of replacement windows: The replacement windows shall be identical in appearance (as close as reasonably possible) to the original construction windows installed by the developer of the Wellesley at Boynton Beach Units. The design and dimensions shall be identical (as close as reasonably possible) to the original construction windows. The frames shall be white. Hurricane impact glass is permitted. However, the glass must be clear and have a clear appearance. The glass shall not be colored or tinted. Further, there shall not be gas or other material between the glass which gives a window glass a colored or tinted appearance or gives an appearance other than clear window glass.

This letter is notification that these restrictions shall prospectively be strictly enforced. You may obtain the application from the Association's management company, Seacrest Services Management (561) 697-4990.
